#### 1.2 Services from Student

The student shall provide the following ("Services") to BOLTC:

- Complete Lessons via the Internet, mail, or on-campus within 60 days of this contract
- Turn in all assignments and meet every requirement within 60 days of this contract

### 2. PAYMENT AND INVOICING TERMS.

#### 2.1 Payment for Services. BOLTC will be paid as follows:

Students shall pay all monies due before courses begin, or in three installments—if approved in writing by BOLTC—as follows: one-third by class-time, another third before the end of the first month; and a final third before the end of the second-month. Students cannot complete the final month of training with any balance outstanding.

Those who pay by installments shall either (1) entrust BOLTC with two postdated checks, for deposit with the consent of the student, or (2) allow BOLTC to charge their credit card twice more on dates set by the student.
